Effectivity :

All ASW 15 Serial Numbers 15 001 to 15 375 inclusive

Accomplishment : See Airworthiness Directive No. 74 - 323 (Rev. 2)

Reason:

1 For all ASW 15 Serial Numbers 15 001 to 15 183 inclusive.

According to above - mentioned directive, all control cables of 3 mm diameter of the rudder control circuit are to replace by new ones of 3.2 mm diameter according to the LN 9374 specification.

The cables of the tewing hooks and the wheel brakes

are not affected.

For all ASW 15 from Serial No. 15 184 to 15 375 inclusive.

Contrary to above - mentioned Airworthiness Directive 74 - 323 (Rev. 2), only the short forward cables 3 mm diameter which lead through the pedals are to replace at the ASW 15 - B by 3.2 mm diameter cable of LN 9374 specification.

The rear cables of the rudder circuit leading through the polyamid tubings in the fuselage sandwich must be replaced by cable of 2.4 mm diameter according to the LN 9374 specification.

The thinner cable has less friction than a 3.2 mm

cable.

The cables of the towing hooks and wheel brakes are not affected by this directive.

Instructions :

For exchange of the central cables the whole pedal unit must be removed from the fuselage.

To: do this, the 6 nuts at the plywood on the floor must be removed.

On ASV 15 s the stops for the rudder circuit on the rear main bulkhead are to remove in order to be able to disconnect the rudder cables.

The new control cables must be manufactured according to the Technical Note for cable connections issued

the 27th November, 1974.

Only two thimble eye splices must be made in the glider (front end of the rear cable for ASW 15 and rear end of the rear cable for ASV 15 - B). The other six cable eyes can be prepared outside of the machine.
