

	Brake hoses of the old type are made from rubber material and have a service life limitation. The material of the new type brake hoses is long-term resistant against the used brake fluid

and thus no service life limitation is necessary.1.) Identification of the installed brake hoses



Brake hoses of the **old type** made from rubber material, identifiable by the shown fitting shape and the textile fabric wrapping of the hose.

Brake hoses of the **new type**, , identifiable by the shown fitting shape.

2.) Specification of the lifetime limitation

Brake hoses of the **old type**: This brake hose has to be exchanged in regular intervals of 6 years. If the brake hose is in good condition, it is not necessary to exchange the hose. Operation on condition requires the inspection of the hose for proper condition at least every 100 h.

Brake hoses of the **new type**: This brake hose has no service life limitation (on condition).

3.) Exchange of the following pages of the maintenance manual

In case brake hoses of the **old type** are installed: No exchange of manual pages. The service life limitation of the brake hoses is already included in the maintenance manual.
